### 2.- COMPOSITION/INFORMATION ON INGREDIENTS.

- SATURATED HYDROCARBONS + COPOLYMERS OF ETHYLENE AND ACETATE OF VINYL + RESINS

### 3.- HAZARDS IDENTIFICATION.

- THIS PRODUCT IS NOT EXPECTED TO PRESENT ANY UNUSUAL HAZARDS IN PROPER USE.  
- THIS PRODUCT IS OFTEN TRANSPORTED AND HANDLED HOT CARE SHOULD BE TAKEN TO PREVENT THERMAL BURNS.  
-TEMPERATURE >200°C THERMAL DECOMPOSITION IN TOXIC PRODUCTS AND CORROSIVE: MONOXIDE OF CARBON - ACETIC ACID.

### 4.- FIRST AID MEASURES.

- INHALATION: NO EFFECTS KNOWN UNDER NORMAL CONDITIONS OF USE.  
- INGESTION: NO EFFECTS KNOWN UNDER NORMAL CONDITIONS OF USE.  
- EYES: WASH WITH WATER. IF IRRITATION PERSISTS, CONSULT PHYSICIAN.  
- SKIN: IF BURNED BY CONTACT WITH HOT MATERIAL, COOL BURNED SKIN AREA AS QUICKLY AS POSSIBLE BY IMMERSING IN COLD WATER, OR APPLYING COLD WATER. CALL A PHYSICIAN.

### 5.- FIRE FIGHTING MEASURES.

- EXTINGUISHING MEDIA: CARBON DIOXIDE, DRY CHEMICAL OR FINE WATER SPRAY AND SAND.  
- SPECIAL FIREFIGHTING PRECAUTIONS: AVOID WATER STREAM ON MOLTEN BURNING MATERIAL AS IT MAY SCATTER AND SPREAD THE FIRE. AN INCORRECT APPLICATION OF THE WATER CAN MAKE THAT THE PRODUCT OVERFLOWS AND EXTEND.  
- RESPIRATORY PROTECTION: RESPIRATOR WITH A MIST FILTER FOR AVOID INHALATION OF WAX GASES.

## 6.- ACCIDENTAL RELEASE MEASURES.

- IN CASE OF SPILLING OUT THE PRODUCT IN SOLID STATE, TO SWEEP THE AREA, AND TO TOSS SAND IF IT WAS NECESSARY.
- IN CASE OF SPILLING OUT THE HOT MATERIAL, KEEP TO THE STAFF FAR AWAY, TO ALLOW TO SOLIDIFY AND TO RECOVER THE PRODUCT FOR THEIR RECYCLING OR REMOVAL.
- TO WARN TO THE AUTHORITIES IF THE PRODUCT GOT INTO SEWERS OR WATER CONDUCTIONS.

## 7.- HANDLING AND STORAGE.

- KEEP AWAY FROM HEAT AND FLAMES.
- DO NOT STORE NEAR STRONG OXIDIZING AGENTS.
- KEEP OUT OF STRONG SUNLIGHT.
- DO NOT STORE AT TEMPERATURES  $>20^{\circ}\text{C}$ .
- EXERCISE SUITABLE PRECAUTIONS TO AVOID THERMAL BURNS WITH MOLTEN MATERIAL.
- THE OCCASIONAL REMAINS IN THE FLOOR PRESENT RISKS OF FIRE, TO AVOID THEIR ACCUMULATION.

## 8.- EXPOSURE CONTROLS/PERSONAL PROTECTION.

- RESPIRATORY PROTECTION: NO SPECIAL RESPIRATORY PROTECTION IS NORMALLY REQUIRED. AVOID INHALATION OF WAX GASES.
- HAND PROTECTION / PROTECTIVE GLOVES: HEAT PROTECTIVE IMPERVIOUS GLOVES WHEN HANDLING MOLTEN PRODUCT.
- EYE PROTECTION: FACE SHIELD OR CHEMICAL SPLASH GOGGLES IN CASE OF SPLASHING.
